Team Matched Poles: Teams, in turn, serpentine through a 6-pole bending pattern, for time. Number of teams will depend on number of entries. Teams decided by draw on the day of event.	\$
Ribbon Race (Mounted partner needed): Rider #1 and rider #2 each hold 1 end of a paper ribbon and walk, trot, and canter without breaking ribbon. Partner: _____	\$
Sack Race (No horse needed): All participants place both of their legs inside a sack and hop from a starting point to the finish line.	\$
Mounted Egg Toss (partner needed): Mounted, riders toss and egg between them and their partner, at increasing distance. Partner: _____	\$
Baton Race (Mounted partner needed): Rider #1 takes baton to end of arena where partner #2 is waiting for the hand off and takes it back across the finish line. Partner: _____	\$
Lifesaver Race: Rider rides to end of arena, dismounts, and finds lifesaver in plate of whipped cream without using hands	\$
Boot Race (No horse needed): All participants remove their boots/shoes; boots are placed in a pile at end of arena. Participants race to find their own boots, put them on, and cross the finish line.	\$
Bobbing for Apples: Rider rides to one end of the arena, dismounts, and using no hands, rider must bob for 1 apple from a barrel.	\$
Fox and Hound (Mounted partner needed): Rider #2 follows rider #1 through a clover leaf barrel pattern, for time. Partner: _____	\$
Rescue Race (Un-mounted partner needed): Rider #1 rides to one end of the arena, helps partner mount and races back to the start/finish. Partner: _____	\$

Waiver

I, the undersigned, understand that Hawaii Revised Statutes Chapter 663B (the *Statute*) limits the civil liability of persons sponsoring Equine Activities (as that term is defined in the Statute, involving a horse, pony, mule, donkey or hinny). I understand that there are inherent risks of injury, including to (1) the propensity of an equine to behave in ways that may result in injury or death to persons on or around them, (2) the unpredictability of an equine's reaction to such things as sounds, sudden movement, and unfamiliar objects, persons, or other animals. (3) hazards such as surface and subsurface conditions, (4) collisions with other equines or objects, and (5) the potential negligence of another participant, such as failing to maintain control over the equine, or not acting within the participant's ability.

Knowing and understanding the risks of participating in an Equine Activity, including injury and death to my person and damage to my personal property, I expressly choose to assume these risks. Further, on behalf of myself, my heirs, successors, person representative, administrators, representatives and assigns, I hereby unconditionally release any and all claims and causes of actions against the Equine Activity sponsor, Gunstock Ranch, Inc., Dana Pang, Greg and Kyndra Smith and their heirs, Hawaii High School Rodeo Oahu District and its officers, Gunstock Ranch employees, agents representative and show personnel, for any injury including death, and for any damage to personal property, which I may incur as a result of my participation in this Equine Activity.

If the undersigned is the parent, guardian or representative of any minor participating in this Equine Activity, the undersigned agrees to indemnify the above-described Equine Activity sponsor (including its/their above described related persons and entities) from any and all claims and causes of action brought by or on behalf of said minor at any time. The undersigned agrees that this instrument is binding on his/her heirs, personal representatives, administrators, representatives, and assigns.
